ORDINANCE NO. 2024-08

AN ORDINANCE OF THE CITY OF MINERAL WELLS, TEXAS  
DECLARING THAT AMENDMENTS TO THE CHARTER APPROVED  
BY THE VOTERS AT THE MAY 4, 2024 SPECIAL ELECTION ARE  
ADOPTED; PROVIDING FOR MATTERS INCIDENTAL THERETO;  
AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Mineral Wells (the “City”) is a Home Rule Municipality acting under its Charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Texas Local Government Code; and

WHEREAS, pursuant to Article XII, Section 149 of the City Charter and Section 9.004(a) of the Texas Local Government Code, the City Council of the City of Mineral Wells, Texas (the “City Council”) may submit proposed Charter amendments to the City’s voters at an election; and

WHEREAS, on January 16, 2024, the City Council ordered a special election for the purpose of submitting proposed Charter amendments to the voters; and

WHEREAS, said special election was held on May 4, 2024 and the results of the election were canvassed by the City Council on May 14, 2024 where it was determined that all proposed amendments to the Charter were approved by a majority of qualified voters voting in the special election, as required by Section 9.005(a) of the Texas Local Government Code; and

WHEREAS, Section 9.005(b) of the Texas Local Government Code provides that a charter amendment does not become effective until the City Council “enters an order in the records” of the City “declaring that the...amendment is adopted”.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MINERAL WELLS, TEXAS:

**SECTION 1. INCORPORATION OF PREMISES.** The above and foregoing premises are true and correct and are incorporated herein and made a part hereof for all purposes.

**SECTION 2. APPROVAL BY VOTERS.** Pursuant to the City Council’s official canvass of the May 4, 2024 special election on the Charter amendments contained in this Ordinance, which canvass was made on May 14, 2024, the Charter amendments contained in this Ordinance have been approved by a majority of voters of the City.

**SECTION 3. AMENDMENTS ADOPTED.** The following amendments to the Charter of the City of Mineral Wells are hereby adopted.

A. Article II, Section 19, Corporation Court is amended to read as follows: “There shall be a court for the trial of misdemeanor offenses known as the “Municipal Court of Mineral Wells, Texas” with such powers and duties as are given and prescribed by the laws of the State of Texas”. The title of this Section shall also be amended to “Municipal Court”.

B. Article VII, Section 74, Sale of City Property is amended to read as follows: "The City shall comply with the laws of the State of Texas in selling real and personal property owned by the City".

C. Article VII, Section 75, Purchase Procedure is amended to read as follows: "The City shall comply with the laws of the State of Texas in making expenditures of City money, subject to an internal purchasing policy that may be adopted by the City Council from time to time".

D. Article VII, Section 76, Contracts for Improvements is amended to read as follows: "The City shall comply with the laws of the State of Texas governing contracting authority of municipalities, including allowable change orders".

E. Article IX, Section 92, Municipal elections is amended to read as follows: "The regular election for the choice of members of the council as provided in Article II, Section 21 of this Charter shall be held each year on the May uniform election day established by the State of Texas. The Council may by resolution order a special election, to be held on a uniform election day established by the State of Texas and provide all means for holding such election".

F. Article X, Section 107, Submission to Electors is amended to read as follows: "If the Council shall fail to pass an ordinance proposed by the initiative petition, or shall pass it in a form different from that set forth in the petition therefor, or if the council fails to repeal a referred ordinance, the proposed or referred ordinance shall be submitted to the electors on the next uniform election day for which adequate time exists to order said election pursuant to the laws of the State of Texas".

G. Article X, Section 114, Recall Election is amended to read as follows: "The City Clerk shall at once examine the recall petition and if he finds it sufficient and in compliance with the provisions of this Article of this Charter, he shall within five (5) days submit it to the city council with his certificate to that effect and notify the officer sought to be recalled of such action. If the officer whose removal is sought does not resign within five (5) days after such notice the city council shall thereupon order and fix a date for holding a recall election. Any such election shall be held on the next uniform election day for which adequate time exists to order said election pursuant to the laws of the State of Texas".

**SECTION 4. CERTIFICATION OF AMENDMENTS.** Pursuant to Section 9.007(a) of the Texas Local Government Code, the Mayor is authorized to certify to the Secretary of State an authenticated copy of this Ordinance.

**SECTION 5. EFFECTIVE DATE.** This Ordinance shall become effective immediately upon its adoption by the City Council.
