rules portion of this packet).

**TEAM MANAGERS' MEETING:** Saturday, April 25<sup>th</sup>, 2020 at the Mineral Wells City Gym at 8:30 a.m. Attendance at this meeting is not mandatory if we have already received your roster. However, it is highly recommended that a representative from each team attend to be as informed as possible concerning all of the tournament procedures.

**T.A.A.F. ROSTERS:** Each team must present an official T.A.A.F. roster form with all players' names, addresses and player information completed on the official T.A.A.F. roster form. Each T.A.A.F. team roster must be signed by the T.A.A.F. city representative. The T.A.A.F. roster must be received by the team manager's meeting at 8:30 a.m. on Saturday, April 25<sup>th</sup>.

### **Texas Amateur Athletic Federation (T.A.A.F.) CO-REC VOLLEYBALL PLAYING RULES**

.01 The serving order and positions on the court at service shall be an alteration of male and female or vice-versa.

.02 When the ball is played more than once by a team, at least one of the contacts shall be made by a female player. Contact of the ball during blocking shall not constitute playing the ball. There is no requirement for a male player to contact the ball regardless of the number of contacts by the team.

.03 When only one male player is in the front line at service, one male back line player may be forward of the attack line for the purpose of blocking.

.04 No female back line player may participate in a block.

.05 The adult co-rec state volleyball tournament will be held either the last weekend in March or any weekend in April, providing that it is not the same weekend as the Easter holiday. This date restriction will be effective with the 2011 T.A.A.F. Co-Rec State Volleyball Tournament and for subsequent years.

### **2020 State Tournament Rules**

1. The City of Mineral Wells will provide a referee, an umpire and a scorekeeper/scoreboard operator for each match. Linesmen will be volunteer players or staff members. If linesmen are not available, the officials may call for a replay if there is a line call or touch that they were not able to see clearly.

2. Teams must fill out a lineup for each match five minutes before the match begins. Any changes between sets must be completed in the one minute between sets.

3. There will be one minute between sets.
4. Uniform jerseys are not required. However, any team substituting by rule must have permanently –affixed jersey numerals on the back of their jerseys.
5. Teams must choose one substitution method for each set. They may choose to rotate or substitute by rule. However, they may not use both methods of substitution in any set.
6. If choosing to substitute by rotation, teams must stay in the same order throughout the set. If a player becomes injured and is unable to continue in the rotation, a side out and a point will be awarded to the opposing team each time the missing player is scheduled to serve in the rotation.
