

ORDINANCE NO. 2025 - 06

AN ORDINANCE DECLARING UNOPPOSED CANDIDATES ELECTED TO OFFICE PURSUANT TO SECTION 2.025 OF THE TEXAS ELECTION CODE; CANCELING ELECTION PREVIOUSLY ORDERED FOR MAY 3, 2025; AND PROVIDING FOR POSTING COPY OF ORDINANCE.

WHEREAS, On February 4, 2025, an election for City Councilmembers was ordered to be held on May 3, 2025, for the following offices:

Councilmember At-Large Place 1
Councilmember At-Large Place 2
Councilmember Ward 2
Councilmember Ward 4

WHEREAS, the deadline for filing to run for said offices has expired; and

WHEREAS, the City Clerk of the City of Mineral Wells, Texas, being the person responsible for the preparation of the official ballot, has certified in writing to the Mineral Wells City Council that only one candidate's name is to be placed on the ballot for each of the offices above mentioned under Section 52.003 of the Texas Election Code and no candidate's name is to be placed on a list of write-in candidates for any of the offices above mentioned under applicable law; and

WHEREAS, only the following named persons have filed for each of the offices above mentioned:


Councilmember At-Large Place 1 - Kyle Wayne Kelley
